Cllr Aitken submitted the following report as she was unable to attend the meeting:

- My CLF fund this year will go towards benches near Ferry Meadows.
- The Civic Awards are taking place on 3rd March 2020 if anyone feels that someone should be put forward for next year's awards then please let me know.
- Gostwick Garden There isn't any planning planned for this site, I think a garden is a great idea as long as it is maintained by the Parish Council and others (not PCC).
- Nene Park's new Activity Centre/Climbing Wall Consultation closed on 7th February 2020, the Case Worker is now reviewing all the documents and there isn't currently a Planning Committee planned.
- Bushfield Court All residents I was dealing with have now been re-homed and have spent their first month in their new properties. They are much happier now.
- Complaints regarding Ortongate Car Park have been received and are in the process of being sorted e.g. the markings and signage.
- Overton Way currently being looked into by PCC Officers. Someone will go round and speak to the resident but this has been an ongoing issue and I suspect will continue unfortunately.

As the land is owned by Peterborough City Council, Paul Robertson is establishing whether the City Council has any long term plans to develop this land before anything can move forward.

### 200/02-20 Oundle Road Bus Shelter

A matter of concern was raised regarding the large amount of old bedding and other items left inside the shelter and amongst other things; it appears that the shelter is being used for the wrong reasons. The shelter belongs to the Parish Council and it was suggested that perhaps the structure needs changing to a different style of bus shelter or find an alternative use for it as it is set back quite a way from where the bus actually stops. Cllr Fearon offered to check the shelter to see is anyone is sleeping in it overnight. It was agreed that if the shelter is empty at night, the Clerk will arrange for the shelter to be cleared.

## 201/02-20 Traffic in general on Cherry Orton Road

A matter of concern was raised regarding the way vehicles purposely mount and damage the grass verges near the junction of Cherry Orton Road/Oundle Road as this part of the road is too narrow for large vehicles to pass by each other. It was agreed that the Clerk will ask Highways for advice regarding this matter.

#### 202/02-20 Parish Council Website

The Clerk informed the meeting that as from September 2020 the Parish Council website will not be compliant with the Government's Website Content Accessibility Guidelines (WCAG 2.1). She has asked Jonathan Frascella who looks after the security of the website, for advice and been told that it may be possible to make the current site compliant but with the existing software being end-of-life it will most likely not be cost-effective. It may be possible to add additional software to provide accessibility functionality however it is not sure how the current site will respond to it.

If a new website is decided upon, the Parish Council can pay for a hosting service which also provides individual email addresses for councillors. In view of this, the Clerk has asked Jonathan to provide a quotation for a new website. Cllr Barrows also offered into looking for a new website provider.

- A local resident reported to the Clerk that they had seen 3 men in their early 20's going into the wooded area with bags, one which was full of beer. They were quite loud and the resident was concerned for children in the play area and lone dog walkers if the men are under the influence of alcohol. As this area has a Designated Public Protection Order (DPPO) in place, the Clerk has reported this to the Police and asked them to come and patrol the area when they can especially at weekends. The resident has also been told to report future incidents to the Police.
- Cllr Proudfoot has sown some more wildflower areas in the meadow area.
- 2 trees have come down in the recent winds. These will be removed by the Parish Council contractor.
