Minutes of the Orton Waterville Parish Council meeting held in the Village Hall, Glebe Avenue, Orton Waterville on Wednesday 26th October at 7.00 pm.

Cllr Barrows was absent from the meeting.

104/10-22 Local police matters

Cllr Knight reported that there are 2 Police Liaison Community Officer's (PCSO's) for the Ortons. She communicates with them once a month on Ward issues. PCSO Lloyd Ledgister is very active and approachable.

105/10-22 Ward Councillor reports

Reports received from Ward Councillor on mutual matters concerning the parish

- **1.** Cllr Knight gave the following report:
 - Cllr Knight is meeting with council officers next week to obtain costings for the grass bunds on Brimbles Way.
 - Contractors have now started work on renovating Homenene House. Prior to this, complaints of vandalism were being received as it had been standing empty for so long.
 - Peterborough City Council (PCC) is carrying out surveys for tree works in the Ortons. Any issues relating to trees or bushes can be reported to Cllr Knight or Cllr Day.
 - PCC has set up a 'Cost of living' crisis group and has information on debt etc., ready to send out to Parish Councils and to those which need it.
 - The Car Cruising report is being presented to the Scrutiny Committee next week. Cllr Knight is on the committee and is able to take forward any questions which councillors may have.

2. Cllr Day gave the following report:

- Cllr Day is conducting weekly 'Meet on your street' visits and is picking up case work from residents. As a result of this, she has requested bins next to bus stops.
- Cherry Orton Road residents are fed up with big lorries using their road and she has raised this issue with PCC.
- A resident is concerned that there were not enough parking spaces allocated on the planning application for 25 Cherry Orton Road. PCC Planning has assured Cllr Day that there is sufficient parking.
- Cllr Day and Cllr Knight have met with Dr Nik Johnson, Mayor for Peterborough and Cambridgeshire Combined Authority, regarding bus services 23, 24 and 29. A different operator has now filled those services. Cllr Day is working on this issue with other 'Greens' in Cambridgeshire.

- Cllr Day has been busy on working groups. A cross party working group is working on the budget which has a £2m budget deficit gap. The budget will then have to be agreed by full Council. Big cuts are being envisaged.
- Cllr Day is being mentored by a local government peer mentor. This is Green Party Peer Mentor who is a Finance Lead for Lewes Council and is supporting Cllr Day's work on the City Council Budget.
- Cllr Day has been on the Car Cruising Task and Finish group. The report is being presented to the Scrutiny Committee on 1st November 2022 with a series of recommendations, of which one is a City wide injunction.

3. Report submitted to the Clerk by Cllr Stevenson:

• Showground

AEPG will be managing two 'soft' road closures at Orton Northgate and Orton Southgate on 29th Oct and 5th Nov to prevent visitors to their events from parking on residential streets. Cllr Stevenson and a group of volunteers have distributed passes to all households affected by the closures to ensure their access.

• Anti-social use of cars

The final report of the council cross-party working group on anti-social behaviour and car cruises (chaired by Cllr Stevenson) will be presented to the Growth, Resources and Communities Scrutiny Committee on 1st November. A copy of the report has been circulated to Parish Councillors.

• Brimbles Way

At the request of staff and residents of Lapwing Apartments in Matley, the council is considering options to introduce a pedestrian road crossing to make it safer for pedestrians walking on the footpath that crosses Brimbles Way.
